Important Information About Calls and Your Choices

If you contact us to request information or ask for a brochure, we may contact you afterwards with a courtesy call to confirm you received the requested material and to discuss whether you would like to be introduced to an FCA-authorized financial adviser.

You remain in control of how we contact you:

- If you choose to opt out, we will cease further contact and retain your details on a suppression list to ensure you are not contacted again in future.

Where you choose to proceed with an introduction to a financial adviser, we will only share your information with your consent, which is recorded when provided.

When You Submit an Enquiry or Request Information

When you complete a form on our website, request a brochure, or ask to be connected with a professional adviser, we may collect information such as:

- Your name

- Contact details
- Information relating to your enquiry or interests

This information is stored securely and used to help us connect you with an appropriate professional adviser.

Our processing of this information is necessary to provide the service you requested and is carried out on the basis of contractual necessity.

If the adviser you initially selected is unavailable, we may attempt to identify another suitable adviser in your area who matches your requirements. Your information will only be shared with professionals relevant to your enquiry and not with unrelated third parties without your permission.

In some cases, if we are unable to complete your enquiry through our normal process, either Adviser Finder or one of our trusted partners may contact you to confirm or clarify your details to help complete your request and improve the likelihood of finding a suitable adviser.
